OSAS BROUGHT THE OREGON SYMPHONY TO SALEM FOR SEVEN CLASSICAL CONCERTS DURING THE SEASON ENDING JUNE 2017. THESE CONCERTS SERVED MORE THAN 6000 PATRONS INCLUDING CHILDREN, SENIOR CITIZENS AND THE UNDERSERVED. WE PROVIDED MORE THAN 550 STUDENTS OF ALL AGES AND OREGON TRAIL CARDHOLDERS (SNAP) \$5 TICKETS (AN AVERAGE DISCOUNT OF \$40) AS A BENEFIT TO THE COMMUNITY AND SUPPORTS STUDENTS AND MUSIC EDUCATION PROGRAMS OF LOCAL SCHOOLS. IT IS OUR UNDERSTANDING THAT SALEM, THROUGH OSAS, IS THE ONLY CITY, WHICH CONTRACTS FOR A SEASON OF CONCERTS WITH A NATIONALLY RECOGNIZED ORCHESTRA, AND THE OVERHEAD FOR ADVERTISING, TICKET SALES, AND OTHER ADMINISTRATIVE EXPENSES ARE COVERED THROUGH DONATIONS AND SPONSORSHIP SUPPORT.

THE SECONDARY GOAL OF THE OREGON SYMPHONY IS TO SUPPORT THE GROWTH AND DEVELOPMENT OF STRONG MUSIC EDUCATION PROGRAMS IN THE LOCAL SCHOOLS. IN THE LAST YEAR, OSAS HOSTED MASTER COACHING CLASSES OFFERED BY OREGON SYMPHONY MUSICIANS IN THE AREA HIGH SCHOOLS, SPONSORED AN ESSAY COMPETITION ON A MUSIC TOPIC FOR ALL AREA ELEMENTARY SCHOOLS. A CONCERTO COMPETITION OPEN TO ALL YOUTH 18 AND UNDER IN THE MID-WILLAMETTE VALLEY WAS HELD, AND OSAS COLLABORATED WITH LOCAL YOUTH SYMPHONIES TO OFFER A YOUNG MUSICIANS SERIES BEFORE THE OREGON SYMPHONY CONCERTS. BECAUSE THE OREGON SYMPHONY MUSICIANS CHARGE FOR THEIR SERVICES AS MASTER COACHES AND ADJUDICATORS, WE SOLICITED CONTRIBUTIONS AND SPONSORSHIPS TO COVER THE COST OF THIS OUTREACH INTO THE COMMUNITY.
